Deputy Administrator Stephanie Landers had no formal business to bring before the Board. She stated that she has applied for the OTARMA grant. In addition, preparations are underway for the Memorial Day Parade on May 25 and Community Day on June 6.

Assistant Fiscal Officer George Platton attended the meeting in place of Fiscal Officer William D. Leicht. Mr. Platton stated that the audit is complete and it went very well. He also stated that we have received the first half of the revenue disbursement. In addition, he distributed the distribution of the revenue and expense reports. Mr. Moliterno commended both Mr. Leicht and Mr. Platton on their hard work stating that he appreciates their experience and attention to detail.

Under Old Business, Mr. Calhoun reminded everyone that the May 11 board meeting will take place at 2:00 p.m. at the Boardman Center Middle School Auditorium at 7410 Market Street.

Under New Business, Mr. Costello stated that Governor Kasich's proposed budget for the State of Ohio will be detrimental to Boardman Township. Much of the money that we pay in taxes used to come back to the Township. Over the last five years, Governor Kasich has slowly eroded what we receive. To illustrate, in 2011, we received \$1.1 million back from the state. By 2014, we received \$576,000. In the proposed budget, Governor Kasich eliminates this entirely, although we are still paying the taxes and the State is putting this money in their "rainy day" fund. When asked if some of this "rainy day" fund could be used to fix potholes, the state refused this request. All of our trustees have reached out to Representative Gerberry and Senator Schiavonni stating that we cannot lose this funding and ask that all Boardman residents contact them also.
