These vests offer protection to officers in situations involving weapons that exceed the capacity of their daily wear body armor. The total cost is \$11,811.00 with \$3,887.00 taken from line item expense # 2081-210-251-0000 that will be reimbursed to the township by individual officers. The remainder of this purchase of \$7,924.00 will be funded by the Law Enforcement Trust Fund #2261-210-420-0000.
