Mr. Calhoun stated that the final appropriations passed tonight are a function of our accounting system for the State of Ohio and do not reflect the actual budget for the Township. The actual budget to run the Township at the start of this year will be \$20,676,382.19.

Road Superintendent Marilyn Kenner had no formal business to bring before the Board. She did state that she is going out to bid for road resurfacing and crack sealing. This is the largest program in the past ten years with over ten miles of road to be resurfaced or crack-sealed.

Fire Chief Mark Pitzer had no formal business to bring before the Board. He did state that the Fire Department is participating in a regional FEMA grant for new radios. Sixteen departments are participating and the grant request is over \$2.5 million with our portion of the request being \$160,000. We have passed the Review portion and are moving to the next step in the grant process. We should know by this summer if the grant is approved.

Police Chief Todd Werth had no formal business to bring before the Board. He did state that the Boardman Police Department has earned all four certifications for the Ohio Collaborative.

Director of Zoning and Development Krista Beniston had no formal business to bring before the Board.

Township Administrator Jason Loree had no formal business to bring before the Board. He did state that the ABC Water and Storm Water District will be awarding the Glen Ridge Project. In addition, an informational meeting will take place in April. An aerial flyover will be taking place and mapping elevations to three inches at the end of March or beginning of April. Lastly, the Army Corps of Engineers will match the \$100,000 of engineering for Cranberry Run. This is part of the funding from the state's \$500,000 to provide for storm water repairs.

Fiscal Officer William D. Leicht had no formal business to bring before the Board other than the distribution of the revenue and expense reports.

There was no Old Business.

Under New Business, Mr. Moliterno recognized Mr. Loree's re-appointment to the 9-1-1 Board. He has been a member of this Board and the Emergency Services Steering Committee since 2014 which is working on building a statewide 9-1-1 system.

Public comment reference proposal to rehire Boardman Police Lieutenant Richard Balog, Sergeant Charles Hillman, and Sergeant Michael Hughes after their retirement through the Ohio Public Employees Retirement System (OPERS). Mr. Calhoun and Chief Werth explained the Retire/Rehire Program.
