#### Test Announcement:

The Boardman Township Civil Service Commission is responsible for administering employment tests for the position of full time entry level police officers in the Boardman Township Police Department. The first step in this process is to submit an initial application to the Commission as outlined below. The second step is to take an employment test which is used to rank order candidates for selection. This test is being administered through the National Testing Network (NTN) where candidates can take the test in person or through an online proctored test during the above open testing period.

Starting salary for new full time patrol officers is \$50,000 annually, with lateral credit for full or part time police experience of up to five (5) years with starting pay at \$60,000. #### Qualifications:

Candidates must be able to analyze situations quickly and objectively and determine the proper course of action. A candidate must have the ability to cope with situations firmly, courteously, and tactfully. All candidates must be 21 years of age at time of final appointment and employment. There is no upper age limit for otherwise eligible candidates for the position of full time police officer. All candidates must be able to follow written and oral instructions, and be able to read and write the English language. All Candidates must be citizens of the United States (or provide proof of their intentions of receiving citizenship).

Prior to final appointment and employment, each candidate must successfully pass an extensive background investigation, a medical examination, a physical agility test, a psychological examination and any other tests deemed necessary by the Boardman Township Civil Service Commission.

#### Physical Agility Test:

No agility/physical fitness test completion certificate is required to register for and take the Boardman Civil Service entry level test. However, prior to any formal job offer by Boardman Township, a candidate must have successfully completed one of the below-listed agility/physical fitness tests in the outlined time frame and provide a copy of the certificate as indicated.

- 1. Successful completion of the OPOTC final Academy Physical Fitness Test standards administered by an approved OPOTC police academy within the last two (2) years from the final day of the civil service testing period (April 19, 2024).
- 2. - Successful completion of the final OPOTC Academy Physical Fitness Test standards (by gender & age group) as administered by the Boardman Township Police Department. #### Veteran's Credit:

Any person who has completed service in the uniformed armed services of the United States who has been honorably discharged or transferred to reserve with evidence of satisfactory service, and who is a resident of this state may file with the Commission a certificate of service or honorable discharge and upon this filing shall receive an additional credit of twenty percent (20%) of the person's total grade given in the regular examination in which the person receives a passing grade.

A person who has been discharged from the uniformed services for medical reasons must submit written proof that said person was completely and honorably discharged from the uniformed services in order to receive Veteran's Credit.

A person is not eligible for Veteran's Credit following an honorable or a medical discharge, unless that person has served on active duty in the armed forces for at least one hundred eighty (180) days.

Proof of satisfactory service or honorable discharge shall be submitted when the application for examination is filed with the Commission, or before the scheduled end date of the examination period. #### Licensure Credit:

Applicants are able to apply for and take the civil service test without having completed an Ohio Police Officer Training Commission (OPOTC) academy or having a current Ohio Peace Officer certification. At the discretion of the Boardman Trustees, a candidate completing all applicable civil service requirements during this testing process, may be selected for conditional employment as a cadet and sent to an area training academy at Township expense and while receiving pay/benefits during that period. Upon completion of training and obtaining a certificate of completion, the employee would start their Boardman Police Department training and probationary period.

Any applicant for original appointment as a police officer, who at the time of certification of the list from the examination possesses a valid certificate from the Ohio Police Officer Training Commission (OPOTC), may file with the Commission such certificate. The Commission shall grant additional credit of twenty percent (20%) of the total grade given in the examination to any applicant who files for the extra credit and qualifies, provided that he or she has first received a passing grade on the examination.

#### **Educational Credit:**

Any applicant for original appointment as a police officer, who at the time of certification of the list from the examination possesses an Associate Degree from an accredited college or university, may file with the Commission acceptable certification of such degree. The Commission shall grant additional credit of five percent (5%) of the total grade given in the examination to any applicant who files for the extra credit and qualifies, provided that he or she has first received a passing grade on the examination.

Any applicant for original appointment as a police officer, who at the time of certification of the list from the examination possesses a Bachelor's Degree from an accredited college or university, may file with the Commission acceptable certification of such degree. The Commission shall grant additional credit of ten (10%) of the total grade given in the examination to any applicant who files for the extra credit and qualifies, provided that he or she has first received a passing grade on the examination.

Educational credit is non-cumulative in nature and cannot be compounded based on multiple degrees of any type. A candidate is only entitled to a single credit for the highest degree recognized and submitted to the Commission prior to the examination date and must, at that time, be accompanied by proof as described above.

<u>Maximum Credit</u> The maximum credit available for any one candidate is 20%, regardless of the sources. Credits from more than one source outlined above cannot be combined if they exceed 20%.

After creating an account, select 'Find Jobs', then select 'Law Enforcement' jobs and sign up for the Boardman Township Police Department test to be taken no later than April 19, 2024. The Boardman Civil Service Police Officer entry test may be taken in-person or by online proctor through NTN.

Candidates achieving the minimum passing score on the NTN entry test will be eligible for bonus points if proper documentation is submitted by April 19, 2024. After reviewing the results of the written examination provided by the National Testing Network, and applying any applicable bonus points, the Boardman Township Civil Service Commission will then compile an eligibility list. The eligibility list will be in effect for a period of one year after the first hire or two years from the date of certification by the Commission.

The top-ranked candidates may be scheduled for an extensive background investigation conducted by the Boardman Police Department which includes candidate interviews, reference checks, criminal history check, credit check, medical assessment, drug screen testing, and psychological assessment.

The Boardman Township Civil Service Commission will be administering an Entry Level Police Officer entry exam from March 11th to April 19th, 2024. The testing for the exam will be administered through the National Testing Network (NTN) <a href="www.nationaltestingnetwork.com">www.nationaltestingnetwork.com</a> which offers a flexible testing schedule which allows candidates to take the exam in person or through an online proctor anytime during the six week testing period. Civil service test points will be added for military service, educational background, and current OPOTC certification. Panel interviews, background investigation, voice stress examination, drug screening, medical physical, and a physical fitness test will follow as the next steps in the employment process.
