BOARDMAN TOWNSHIP TEST FOR ENTRY-LEVEL FIREFIGHTER/EMT-B (Medic trainee)

The Boardman Township Civil Service Commission will be administering an Entry Level Firefighter/EMT-B entry exam **from August 1, 2025 to midnight of September 5, 2025**. The testing for the exam will be administered through the National Testing Network (NTN) www.nationaltestingnetwork.com which offers a flexible testing schedule which allows candidates to take the exam in person or through an online proctor anytime during the three-week testing period. Additional information can be found at the Boardman Civil Service website www.boardmantwp.com/civil-service. Civil service bonus points will be added for military service and educational background with a passing score (65%). The top-ranked candidates may be scheduled for an extensive background check, drug screen testing, and psychological assessment.

Application Steps

Meet all minimum requirements as outlined in the Boardman Civil Service FF/EMT-B (Medic trainee) Application.

Go to the Boardman Civil Service website at https://www.boardmantwp.com/civil-service/ to obtain a FF/EMT-B (Medic trainee) application. You may also find the application at the Boardman Township FF/EMT-B (Medic trainee) NTN job posting below or pick one up at the Boardman Township Civil Service Commission (Boardman Fire Department building), 7440 Market Street, Boardman, OH 44512.

Go to the National Testing Network and create an account at www.nationaltestingnetwork.com. If you already have an NTN account and have taken their Firefighter test, request that your results be added to and submitted for the Boardman Township Firefighter/EMT-B (Medic trainee) test.

After creating an account, select 'Find Jobs', then select Firefighter' jobs and sign up for the Boardman Township Firefighter test to be taken <u>no later than midnight on September 5, 2025</u>. The Boardman Civil Service Firefighter entry test may be taken in-person or by online proctor through NTN.

When you visit the www.nationaltestingnetwork.com website:

- · Complete the NTN registration process and schedule your test.
- Review all information related to the Agency Name (position title), including minimum requirements, salary, and benefits.
- Review detailed information about the testing process.
- Review the Frequently Asked Questions and take an online practice test (if desired).

The candidate must complete and submit the formal Boardman Civil Service Commission application for employment and the below forms if applicable to their NTN account or to the Boardman Civil Service Commission no later than September 5, 2025:

- If applicable, copy of DD-214 Member 4 Copy for Veteran's preference points.
- If applicable, copy of current FFII & EMT-B Certificate
- If applicable, copy of two-year (2) Associate's Degree.
- If applicable, copy of four-year (4) Bachelor's Degree.
- If applicable, copy of TRI-C physical fitness certificate (within 2yrs of Sept. 5, 2025).

The above items (Civil Service Application, DD214 Member 4 Copy, FFII and EMT-B Certificate, Educational Benefit, Physical Fitness Certificate) may be submitted <u>using one of the following methods:</u>

Candidates achieving the minimum passing score (65%) on the NTN entry test will be eligible for bonus points if proper documentation is submitted <u>no later</u> than midnight on September 5, 2025. After reviewing the results of the written examination provided by the National Testing Network, and applying any applicable bonus points, the Boardman Township Civil Service Commission will then compile an eligibility list. The eligibility list will be in effect for one year after the first hire or two years from the date of certification by the Commission.

The top-ranked candidates may be scheduled for an extensive background check, drug screen testing, and psychological assessment.

What to expect at the National Testing Network, Inc. website:

- Schedule your own convenient test time. Tests are offered multiple times a week at testing sites throughout the United States including for local area applicants.
- Individual online proctored tests are available with multiple appointment dates & times
- Take high-quality job simulation tests in a standardized, fair testing environment.
- Upon completion of the entry-level exam, all candidate scores are automatically forwarded to the Boardman Township Civil Service Commission. Candidates who attain a passing score on the entry-level exam in each category will be placed on the Civil Service Commission's preliminary eligibility list.

The National Testing Network is a service provided to conduct our entry-level testing in a standardized, accessible, and professional environment. The National Testing Network does not replace the Boardman Township Civil Service Commission's responsibility and decision-making in the testing process. Upon completion of your scheduled exam, scores are automatically forwarded to the Commission. Candidates who attain a passing score on the entry-level exam will be placed on the Boardman Township's Civil Service Firefighter/EMT-B (Medic trainee) eligibility list at the conclusion of the open testing period (September 5, 2025).

A representative from the Boardman Township Fire Department will contact candidates on the list and will invite them to participate in further stages of the selection process. The final hiring authority for the position of Firefighter/EMT-B (Medic trainee) is the Boardman Township Board of Trustees.

To be considered, candidates are required to take the NTN test and file all documents as outlined above <u>no later than midnight on September 5</u>, <u>2025</u>. Candidates who have not met this deadline will not receive consideration for employment.

<u>Maximum Credit</u> – The maximum credit available for any one candidate is 20%, regardless of the source. Credits from more than one source cannot be combined if they exceed 20%.

<u>Veteran's Credit on Open Competitive Examination:</u> Any person who has completed service in the uniformed services who has been honorably discharged from the uniformed services or transferred to reserve with evidence of satisfactory service, and who is a resident of this state, may file with the Commission a certificate of service or honorable discharge and upon this filing shall receive an additional credit of twenty percent (20%) of the person's total grade given in the regular examination in which the person receives a passing grade.

A person who has been discharged from the uniformed services for medical reasons must submit written proof that said person was completely and honorably discharged from the uniformed services in order to receive Veteran's Credit.

A person is not eligible for Veteran's Credit following an honorable or a medical discharge, unless that person has served on active duty in the armed forces for at least one hundred eighty (180) days.

Proof of satisfactory service or honorable discharge shall be submitted when the application for examination is filed with the Commission, or before the scheduled date of the examination. This deadline may be waived by the Commission in specific and unusual situations whereby the Commission believes an extended submission date is justified.

Form DD214 Member 4 Copy is the standard form, which proves **honorable** service or discharge from the Armed Forces of the United States.

The Commission shall grant additional credit of five percent (5%) of the total grade given in the examination to any applicant who files for the extra credit and qualifies, provided that he or she has first received a passing grade on the examination.

Any applicant for original appointment for firefighter, who at the time of certification of the list from the examination possesses a Bachelor's Degree from an accredited college or university, may file with the Commission acceptable certification of such degree. The Commission shall grant additional credit of ten (10%) of the total grade given in the examination to any applicant who files for the extra credit and qualifies, provided that he or she has first received a passing grade on the examination.

Educational credit is non-cumulative in nature and cannot be compounded based on multiple degrees of any type. A candidate is only entitled to a single credit for highest degree recognized and submitted to the Commission prior to the examination date and must, at that time, be accompanied by proof as described above.

Assists the public with fire safety prevention, CPR, etc.; maintains positive public relations; contacts the general public (e.g., vendors, repair shops) and government agencies in order to obtain or disseminate information related to the essential position functions; participates in regular fire prevention training; conducts routine preplans of buildings; completes documentation on preplans.
- 4. Inspects and ensures proper operation of medical and firefighting equipment (e.g., trucks, pumps, hoses, self-contained breathing apparatus (SCBA), foam generating equipment, etc.); makes adjustments to equipment as necessary; performs other related general station custodial work if necessary.
