Parents Comments

No sidewalks in our neighborhood (and along most of the route to school) along with no street lights would make it very difficult to walk or bike to school. Even the high school in the district, which is pretty close to our house, wouldn't be possible to walk/bike to due to lack of sidewalks and lighting along the route.

My daughter has a developmental delay, therefore I do not feel comfortable letting her walk or bike to school.

Walking in most areas of our school district is not possible due to lack of sidewalks and very busy routes.

It would be nice if there were sidewalks on both sides of the street on Glenwood Ave where the school is located.

There are no sidewalks on our street - Sugartree.

Our district does not allow walkers or bike riders. We have many high traffic roads in and around our schools. There are some sidewalks near our schools but only those neighborhoods directly adjacent to the buildings. Living farther away makes it difficult to send kids on a bike or walking without the worry of a safe route to school.

My child drives himself to and from school.

We have no sidewalks on our street so those would have to be put in place in order for the child to want to bike or walk to school. Plus crossing guards at all intersections. Plus at the elementary level you would need parents to help walk the children to school. At the middle school level the children would not need the parents. Any child who lives a mile from school should be bussed in and any child who lives less then a mile should walk or bike to school weather permitting.

I have 2 daughters, one in 6th and one in 7th, their bus rides are around an hour each way.

Absolutely do not support my child walking to school. Too many pedophiles and sociopaths in this society.

We live too far away and the roads are too busy for my student to ride bike/walk to school. By the time she is old enough, she will be in middle school - even farther away. If we lived nearer to the school it may change my mind. Climate also has a large impact. Especially now.

Why don't you have busing for the pre-k kids? Having to deal with a small parking a lot to drop off and have kids stand out in the cold is not safe. Plus already have a kid going to school that is on the bus that could take my other kid.

When I was younger we didn't have concerns about children walking, now kids are took everyday!!

I do not feel it is safe for my child to walk or ride a bike to school. On Market St. she would pass by a motel and weekly rental apartment complex. This is very unsafe for our children.

While we live in close proximity to the school, the business of the street and concern about the child's personal safety (abduction, hit by a car, etc.) would prevent walking.

If there were no busing I would drive or find some transportation but I would not let my daughter walk to school.

My child is a car rider in PM due to time spent on bus in PM and how close we are to school.

I have 3 daughters in K-8. We live in a town that has had connections to drug & traffiking rings. There are 2 seedy Motels within 1/2 mile of our home where drugs are being sold & used & prostitution is prevalent. This greatly affects my decision to NOT let my daughters walk alone to school.

We are too far away from the school to even consider an option of walking/bike riding.

I think that sidewalks and safe intersections are extremely important for neighborhoods. Unfortunately my neighborhood does not have either. I would definitely take advantage of having sidewalks and encourage my kids to walk and ride to school

This neighborhood is not safe for an elementary child to walk or bike to school.

I am a dietitian and understand this is a healthy option but do not feel it is safe unsupervised in todays society. Also do not feel my son is mature enough to get himself home.

I do not feel children especially in elementary school should walk or bike to school unless they live very close and are accompanied by a parent.

We live to far from the school for walking or riding a bike. Under NO circumstance would we allow its at any age.

I don't know when I would allow him to walk to school, he's my oldest and he's only in 1st grade. We live 1/2 mile from the school and its an easy walk. I hope to one day allow him to walk. He's just too young right now.

Should be stop lights in front of the school. People speed and go through stop lights to get to the mall. Unsafe! Neighborhood has too few street lights. Very dark!

Between needing to cross a very busy street and being an assault survivor , I am not comfortable with my children walking to school whatsoever.

I would not allow my children to walk to school especially in elementary school. There's too many sex traffickers.

Being that my children would have to cross Market Street, I would never feel comfortable having them walk to school. It would be great to see improvements along the streets that surround the school! It would be fun to feel safe to walk or hike!

I walked to Jr. High + High School, but I lived night down the street and I feel that times were much safer then (less child predators, etc.) I doubt that I would let my children walk or ride a bike therefore unless there was a strong police presence along their route (+ not until high school).

I prefer to take my kids or have them ride the bus. Too many pervs in this world. Too many crazy people who prey on children.

I think children should be active but we live too far for this to be safe.

would trust my child to walk/ride but the routes they would have to take to any of their schools are too dangerous due to traffic/major roads/high speeds

Our road and the route to school is 2 very busy roads. The distance to walk and safety discourage us from allowing our children to walk.

I would never feel comfortable having my children walk to school. We voted for an emergency tax levy so our kids could ride a bus to school.

The schools in Boardman are too far from the homes to walk or ride a bike. Our town is not designed for students to ride their bikes to school. You should research the Woodlands Township in Houston, TX; they have a wonderful system in place for students to walk and ride their bikes to school.

My children will never be allowed to walk or bike no matter what!

My child lives 10 miles from school; walking or biking is not an option.

Walking and biking are healthy, but may be dangerous and unsafe for kids.

This would be a question I would have to be asked again in several years. As an elementary student, my child would not be allowed to walk/bike even if we lived next door.

Most of our roads don't have sidewalks. I feel that riding the school bus is the best choice for our family since we don't live close enough to a safe sidewalk.

I feel like this isn't a safe option. There are too many dangerous situations that children are exposed to including risk of abduction. Boardman has an excellent bus system; please don't ruin that.

With the extremely high rate of human trafficking in this area, I wouldn't feel comfortable with my child walking home.

Plus, there aren't sidewalks for the majority of the way.

My biggest concern are other drivers texting while driving while my child walks or rides their bike to school.

Once she is older I would be more than happy to let her walk to school given good weather.

My children ride the bus to and from school daily and are picked up and dropped off at the end of our driveway; I expect this to continue.

I would have allowed my older children to walk to and from school starting at 7th grade but it was not permitted at the time by the school. I believe it's too far for younger than 7th grade.

My son is only 9yr old; he doesn't know how to get to school via walking and he doesn't know how to ride his bike. If he walked down Glenwood Ave to get to school he would pass a registered sex offender's home. I believe walking or bike riding to school would be a scary experience for him and my husband and I. There are too many crimes against children and sexual trafficking in our area.

I'm not opposed to kids walking to or from school, but I like the bus for the weather we have here, and also, because we are off of a main road.

The sidewalks would need to be improved and/or added to make them straight and continuous with better marked cross walks.

I don't allow my child to walk home from school until at least 8th grade.

I would like to see upgraded sidewalks and cross walks; there are too many uneven and dead end sidewalks.

I wouldn't let my elementary aged child walk to school.

Afterschool Daycare Bus. Children not permitted to walk alone. I would like my children to be able to walk to school as I can watch them from my front porch, but they are not permitted to walk alone to school.

If the school district didn't supply busing for my children to and from school I would move to a different school district.

Unfortunately, things aren't how they used to be. I don't care how old my children are, I would never allow them to walk or ride bikes to school.

I feel it's very unsafe for children under high school age to walk or ride bikes to and from school. Too many things can happen; kidnapping, human trafficking, etc. going on in the world.

I like having the kids ride the bus.

If the distance wasn't a factor, I would allow my kids to walk to school assuming other safety concerns were met.

I think they need to have bus aides on the school buses (elementary schools)
