### **RESOLUTION**

#### **Establishing a Youth Curfew in Boardman Township**

**WHEREAS**, Ohio Revised Code Section 505.89 provides that a Board of Township Trustees may adopt a curfew for persons under eighteen years of age in any of the unincorporated areas of the township;

**WHEREAS**, a significant number of youths, a percentage of whom are under 18 years of age, are loitering and idling in or upon public streets, places of amusement, entertainment and business, vacant lots and parking lots, and other private property at unreasonable and unacceptable hours;

**WHEREAS**, the Boardman Township Trustees thus declare it a necessity, for the preservation of the public peace, health, safety and welfare of the Boardman Township community, to adopt a Resolution and related provisions establishing a Youth Curfew:

**NOW, THEREFORE, BE IT RESOLVED**, that no minor under the age of 18 years shall loiter, idle, wander, stroll, play or be in or upon the public streets, places of amusement and entertainment, vacant lots, or any other private property, or unsupervised places between the hours of 12:00 AM and 6:00 AM local time.

**BE IT FURTHER RESOLVED**, that the provisions of this Resolution do not apply to minors under 18 years of age who are on their own property or are accompanied by his or her parent, guardian, or other adult over the age of 21 years of age having the care and custody of the minor(s);

**AND, BE IT FURTHER RESOLVED**, that any person under the eighteen years of age who violates this curfew adopted by the Boardman Township Trustees under the authority of the Ohio Revised Code 505.89 shall be charged as being an unruly child and taken before juvenile court as provided in Chapter 2151. of the Ohio Revised Code.

It was moved by Mrs. Mancini and seconded by Mr. Houser, that the foregoing Resolution be approved this 29<sup>th</sup> day of April, 1996.


